Employee must use a personalised leap card which can be ordered online at www.leapcard.ie. Please allow 4/5 days for receipt of your card and order in advance of your TaxSaver application as Leap card number is required with your application. ***We recommend that you register your leap card as this will protect you in the event of loss or theft and you will also be in a position to view your transaction history online.***

Employers will receive email confirmation that TaxSaver ticket has been loaded to Leap Card along with Invoice to the email address quoted above.

TaxSaver ticket will load to card when presented on the Ticket machine on board our coach. ***(Note: TaxSaver ticket can be loaded to Leap card at any stage prior to start date but will not be valid until start Date of ticket)***

Failure to settle the invoice may result in the ticket being confiscated from the user by a member of staff.

Tax Saver Terms & Conditions:

- ***Valid on the Collins Dublin Commuter Service only. Not valid on concert services***
- ***Tickets are not transferrable***
- ***Does not guarantee the employee a seat on any of our commuter services***
- ***Misuse of the ticket will result in the ticket being confiscated***
- ***Tax saver tickets may be refunded. Only remaining whole months will be refunded upon instruction from the Employer, and refunds will issue directly to the Employer. A cancellation fee of €100 will apply***
